Summary of organisation and management structure:

The RTO was granted registration on the 23 June 2015 for seven years and be required to re-register on the 22 June 2022.

Mazda Technical Training Australia Pty Ltd is applying for initial registration and is fully owned by Mazda Australia Pty Ltd. The current Director has established the organisation which is planned to be an enterprise RTO. The Organisation has been registered before but allowed its registration to lapse in 2010.

The organisation's Management structure consists of the General Manager who is assisted by:

- · Administration Manager;
- Training Co-ordinator; and
- · RTO Support Officers.

The organisation utilises a Mazda Advisory committee to assist them with developing and validating training and assessment.

The organisation's scope of registration is limited to the single qualification, the *AUR30616 Certificate III* in Light Vehicle Mechanical Technology.
